
**PROPOSED ORDER GRANTING UNOPPOSED MOTION  
FOR AUTHORITY TO MAKE ADDITIONAL DISTRIBUTIONS  
FROM THE SETTLEMENT FUND**

Having reviewed the Motion for Authority to Proceed with Additional Distributions of Settlement Funds (the "Motion"), the Second Distribution Affidavit of Barbara Heald of the Garden City Group, Inc., and accompanying CD ROM (the "Heald Affidavit"), and good cause appearing, it is hereby ORDERED that pursuant to the Court's June 12, 2003 Order and Final Judgment, the Settlement Agreements and the seller and buyer allocation formulas incorporated therein, the Court hereby:

- (a) Approves implementation of the Undeliverable/Uncashed Check Procedures as proposed by GCG;

- (b) Approves a \$20 minimum check amount for eligible claimants in connection with the Second Distribution;
- (c) Approves the proposed Second Distribution from the Settlement Fund as described above and provided for in the Settlement Agreements in the amount of approximately \$3,199,896.69 to be paid to the 36,643 Seller Eligible Class Members identified in the CD ROM accompanying the Heald Affidavit, filed in connection with the Motion;
- (d) Approves the proposed reimbursement of notice and administration costs and expenses in the amount of \$4,773,363.70, to be paid on a 50% to 50% basis to Defendant Sotheby's and Defendant Christie's from the Settlement Fund;
- (e) Approves the payment by the Settlement Fund of bank charges, estimated at approximately \$140,000.00, to be incurred in making the Second Distribution payments in each Class Member's own domestic currency, wherever reasonably possible; and
- (f) Authorizes the Parties to undertake all steps necessary in accordance with the Settlement Agreements and the Escrow Agreement to effectuate this Order.
